

District Level Public Health Review Meeting at Alipurduar on 10th May, 2019

Introduction:

Tobacco use continues to be the leading global cause of death and threatening to become an uncontrollable epidemic with 13 lakhs deaths every year due to Tobacco diseases. As a result Tobacco related mortality is increasing day by day. Economic burden (both Direct and Indirect) of Tobacco use India, is estimated Rs.1,04,500 crores per year. In this context Tobacco Control Programme aims to reduce diseases, disabilities and deaths related to tobacco use. In this perspective **MANT** for supporting the Police authorities has been for establishment of an effective and efficient system of Tobacco Control in West Bengal.

Planning:

According to the letter from Jt. Director of Health Services (NCD), Memo No. HFW-27026/10/2019-NCD SEC-Dept. of H&F/NTCP-08 Dated 27.03.19, Executive Director, MANT approached the Dy. CMOH II, Alipurduar to participate in the discussion regarding NTCP issues at the District Level PH meeting with Special emphasis on Capacity Building and Enforcement of COTPA, 2003 for the Health Officials of Alipurduar. After several discussions with the Dy. CMOH II, a date has been finalized for the meeting. The meeting was held on 10.05.2019.



Focus:

The main focus of the programme was to orient and sensitize health officials of Alipurduar district, regarding the health & economic burden of tobacco use and about a comprehensive enforcement strategy for the implementation of **Cigarette and other Tobacco Product (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003** which can significantly reduce or eliminate the exposure to smoking.

- The Health & Family Welfare Department would arrange a Debate competition, Poster competition and Essay writing competition among the School and College students of Alipurduar.

Feedbacks:

All the health officials committed that they would take required initiatives to make their district Smoke-free as soon as possible. It was further decided that enforcement would be taken place by the Enforcement Squad at regular intervals in the district. Required support would also be provided by the police for smooth running of enforcement drives by the Block level squads.
